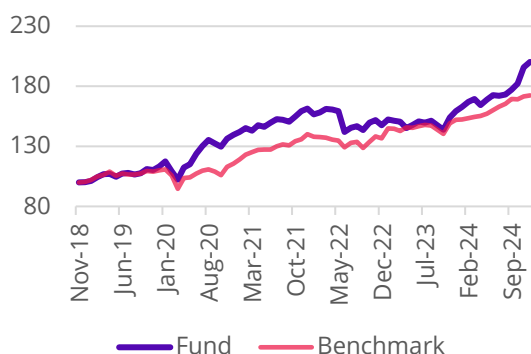


## About the Fund
